Equipment Rental Contract

PLEASE READ CAREFULLY BEFORE SIGNING

1. The registered camper and the parent/legal guardians signing this Equipment Rental Contract are collectively considered and referred to as the “Renter” in this contract.
2. A completed Equipment Rental Form and signed Equipment Rental Contract must be submitted at least two weeks prior to scheduled trip.
3. All equipment rentals must be paid in full before equipment is picked up from Big Sky Bible Camp.
4. Equipment can be picked up at Big Sky Bible Camp up to one week prior to trip to allow for packing and trip preparation.
5. Equipment should be returned in clean and dry condition. A cleaning fee may be charge if excessively dirty.
6. The Renter assumes sole liability for any injuries or damages sustained by him/her, or by others, while using any of the rented equipment. Any claim about the unsuitability of the rented equipment is limited solely to the refund of the rental fee.
7. The Renter is solely responsible for any **damages, loss or theft** of the rented equipment. If deemed necessary by the staff of Big Sky Bible Camp, a replacement cost, of up to the full retail value, may be assessed and billed to the Renter.
8. The Renter agrees that the rental equipment is rented “**AS IS**” condition; and has the responsibility to examine the equipment prior to accepting the equipment. **Renter is encouraged to thoroughly check the equipment when receiving it to make sure that it is in good working condition and complete.**

In consideration of the equipment furnished to Renter, I hereby release Big Sky Bible Camp, BCM International and any personnel of either, from any and all liability for injury and/or accident that may occur while this equipment is being rented. I assume all risks. I understand that I am to examine the equipment for fault, malfunction, defects or missing parts before accepting the equipment for use.

Furthermore, I understand that I am solely responsible for the proper care and handling of the rented equipment to me and for the conduct of those persons using the equipment while rented by me, the Renter. I assume all responsibility for damage, loss, or theft of the rental equipment incurred during the entire rental period, including transport, trip preparations, pre-trip activities or the loading, unloading and use during the entire duration of any backpacking trip that is caused by negligent or careless use. I agree to pay for all repairs or replacement of the equipment if damaged or lost under such conditions.

Finally, I accept that Big Sky Bible Camp, nor its personnel, is not responsible for any of my personal equipment which may be damaged as a result of using the rental equipment and that their insurance will not cover any losses.

I, THE UNDERSIGNED, HAVE READ AND UNDERSTAND THIS RENTAL CONTRACT AND AGREE TO BE BOUND BY THIS CONTRACT TO THE FULL EXTENT ALLOWED BY LAW.
